AMA Fee Schedule

EFFECTIVE DATE: August 1, 2025

REGULAR HOURS: 7:00 AM to 3:00 PM Monday through Friday except holidays.

REGULAR HOURLY RATE: \$35.10 per hour per person.

Rates are assessed in quarter hour increments. SCI reserves the right to determine the number of personnel to properly provide the service requested.

OVERTIME HOURS: One and one-half the regular rate for work performed on Saturday and other than regular hours.

SUNDAY and HOLIDAY HOURS: Two times the regular rate. Holidays are: New Year's Day, Presidents Day, Memorial Day, 4th of July, Labor Day, Thanksgiving Day, Christmas Day, and after 11:00 AM on Christmas Eve and New Year's Eve. Holidays which fall on Saturday will be celebrated on the preceding Friday, those which fall on Sunday will be celebrated on the following Monday.

STANDBY RATES: Will be charged at the applicable hourly rate for delays not caused by the agency. A minimum call out charge of four (4) hours will be assessed at the applicable hourly rate for service outside of regular hours.

MILEAGE RATE: The IRS standard mileage rate will be assessed per vehicle for all services performed basis service point's city limits. Any change to the mileage rate is effective when the IRS changes its standard rate. Mileage may be prorated when more than one point is provided service per trip.

LATE PAYMENT FEE: 1.5% per month may be assessed on all past due balances with a minimum charge of \$10.00.

Commodity Cooperative Service Agreement Fees: In addition to all other applicable fees, commodity cooperative service agreement fees for commodity inspection services (pulses, hops, and miscellaneous processed commodities), excluding rice, will be assessed at the current percentage rate identified in FGIS Directive 9180.74 (Service Fees and Billing Codes, Attachment 4.) The assessed fees must exclude travel, mailing expenses, and state and local taxes. Invoices will identify assessed commodity cooperative service agreement fees as separate line items.

AMA Rice Cooperative Service Agreement Fees: In addition to all other applicable fees, AMA rice cooperative service agreement fees for rice inspection services will be assessed at the current percentage rate identified in FGIS Directive 9180.74 (Service Fees and Billing Codes, Attachment 3.) The assessed fees must exclude travel, mailing expenses, and state and local taxes. Invoices will identify assessed AMA rice cooperative service agreement fees as separate line items.
