(LAST REVISED JANUARY 1, 2026)

The participants listed below have been evaluated by the United States Department of Agriculture, Agricultural Marketing Service, and have been found to be in conformance with the requirements of USDA, AMS Laboratory Approval Program for Export of Animal Origin Food Products (LAP-Export). The LAP-Export is to assure participant laboratories perform validated confirmatory analysis of chemical residues, microorganisms, and parasites in pork, beef, goat, sheep, poultry and game animal (bison, deer, elk, and rabbit) products. Approval is granted on an analyte basis, not by country.

NOTE: The Laboratory Approval Program for Export of Meat and Poultry Products was rebranded to the Laboratory Approval Program for Export of Animal Origin Food Products, effective 1 January 2025. The rebranding facilitates the Program's scope expansion to include analysis of chemical residues for stilbenes and thyreostats; and the commodities of goat, sheep and game animals (bison, deer, elk, and rabbit).
