Almonds, peanuts, and pistachios are to be analyzed for mycotoxins by a USDA (AMS) or USDA (AMS)-approved laboratory. The participants listed below have been evaluated by the United States Department of Agriculture (USDA), Agricultural Marketing Service (AMS), and have been found to be in conformance with the requirements of USDA, AMS Laboratory Approval Program for Analysis of Mycotoxins (LAP-Mycotoxins). The LAP-Mycotoxins is administered to ensure participant laboratories perform validated analysis of aflatoxins in almonds, peanuts, and pistachios and OTA in pistachios.

NOTE: The Laboratory Approval Program for Analysis of Aflatoxins (LAP-Aflatoxins) was rebranded to the Laboratory Approval Program for Analysis of Mycotoxins, effective January 2023. The rebranding facilitates the Program's scope to include analysis if ochratoxin A in Pistachios destined to the European Union; and allows for future program expansions.
